Mise Eire Dancers SAFETY, SAFETY, SAFETY

Our highest priority at Mise Eire is to ensure the safety of every dancer and staff member. A **2020 Health & Safety Guide** outlining protocols and procedures will be forthcoming in your **Mise Eire Dancer Packet** prior to the start of dance/camp, however, in an effort to help answer some frequently-asked questions, please refer to the below.

Be advised that this information is subject to change as our plans are pending approval by NYS State and by Nassau and Suffolk Department of Health. In addition, safety guidelines can change pending developments and enforcement by our local health departments.

Based on the current Department of Health Guidelines, the following protocols will be implemented, but are subject to change at any time:

Limiting Dancers: We will be limiting the total number of dancers in each location of the building to ensure a safe environment, where recommended social distancing can be made possible. Dancer registrations will be admitted on a first come, first-served basis. We need to keep dancers together in assigned groups/pods for the week so please indicate friends or classmates you would like to be in class with. We will *TRY* our best to accommodate.

Group Size: Dancers will be limited to groups of 10 or less, and supervised by our trained instructors based on mandated staff-to-camper ratios .

Wellness Screenings: Dancers will be screened upon arrival at dance each day, including temperature.

Social Distancing: Dancers and staff will practice physically distancing and will avoid mixing with bigger groups around campus.

Personal Protective Equipment (PPE): Staff that in are within 6-feet of your dancer will be required to wear PPE during the camp day. Dancers will be required to wear masks indoors when not dancing and distancing. Please note this is subject to change per health guidelines.

Medical information: Like every summer, we will require a form to note any allergies and emergency contacts for each dancer.

Training: Our staff have been trained to adhere to safety protocols of **COVID-19**.

Signage: Designated areas of the facilities, both indoors and outdoors, will be marked with signage for dancer, social distancing markers, and temporary closures in an effort to protect campers and others.
